The Spectrum of Belief

I had the privilege of attending the 2009 Crash Retrieval Conference in Las Vegas where I presented two different lectures, one of which was UFOs 101. At first, I was hesitant to accept the offer because I felt that lecturing on the basics of Ufology would be preaching to the choir, but I took up the challenge as a way to educate even the veterans among us on what MUFON does in the field, and what uniquely positions us to lead the way.

As part of my lecture, I clarified the often misused term "debunker" in the context of UFO investigation. On the spectrum of belief, we find "believers" on one end who know for certain what UFOs are, who their occupants are, and possibly even what their agenda is. On the other end of the spectrum are the "debunkers" who may be in the guise of the skeptic, but who know that UFOs can be prosaically explained.



COVER STORY . . . Submitted by Donald R. Burleson Ph.D.

Editors Note: Last month the Journal reported the death of Lonnie Zamora (1933 - 2009) a former Socorro, New Mexico police officer on Monday, November 2, 2009 due to heart failure. Lonnie Zamora was known for his report of a close encounter of the first, second and third kinds in 1964, near Socorro, New Mexico. Zamora received extensive media coverage for his report which is often cited as one of the best documented accounts of the event. This month more about the Socorro incident is given as covered by feature speaker, author and writer Donald R. Burleson, Ph.D

Socorro and the Logic of Proof

In the November 2008 issue of the MUFON UFO Journal I presented an article titled "Some Thoughts on the Socorro Object." I argued that because photos were taken roughly fourteen hours apart at the Lonnie Zamora site, with the earlier film reportedly fogged and the later film not, one could use an exponential decay formula to determine that any film-fogging radioactive materials present at the Socorro site would have had a halflife with an upper bound of about two to six hours. I also pointed out that if the Socorro gully was irradiated in 1964 (enough to fog the film) by a process of nuclear power generation, then the half-life would be problematically short.

My thanks to Douglas Wilson in the January 2009 issue of the Journal for picking up on the subject and commenting on my research. We agree that solid science is the face that the field of UFO studies needs to show to the world. I believe, however, that we have somewhat different views about the nature of typical scientific thinking.

While Mr. Wilson applauds my application of mathematical principles to the Socorro problem, he expresses concern that these arguments may not meet with approval in the mainstream scientific community because of standards necessary for "proving" conclusions. Basically the point is that rather than stating anything about Socorro as absolutely known (which I believe would have been intellectually dishonest on my part), I employ conditional or contingent thinking: if something were known to be true, then something else would follow.

Mr. Wilson accurately summarizes one segment of my argument as: "if the flash involved radioactive emanations, and if said emanations produced a radiation field intense enough to fog film, and if those emanations had sufficiently dissipated so as not to fog subsequent film, then there would be intriguing implications about the half-life of the materials involved." This is indeed the gist of my argument, but his concern is that such contingent reasoning would strike mainstream scientists as inadequately rigorous.

The fact is that, in one way or another, all scientific thinking is contingent: if one makes certain provisional assumptions, then certain results are implied. For example, in physics one generally assumes what one may call the universality postulate: that the laws of physics work the same way everywhere in the universe. Although it is probably not possible to prove this absolutely, one reasons that if it's true, then (e.g.) analysis of the spectra of distant stars tells us certain reliable things about the chemistry of those stars.

I'm a mathematician by profession, and I have exceedingly high regard for the necessary rigor of genuine proof, but even in mathematics the thinking is conditional. If the Riemann Hypothesis (to date never proven) is true, then certain other things are too. If one assumes the Axiom of Choice, then certain theorems follow. That some things logically would follow, from other things, is what we know.

Socorro and the Logic of Proof (cont.)

As Mr. Wilson hints, premises can be iffy, and however carefully one proceeds in mainstream science, the reasoning does not always lead to reliable results. You're told that eating eggs raises your cholesterol, and later you're told that eating eggs does *not* raise your cholesterol after all; both results came from careful biochemical research. There are impressive scientific arguments both for and against the reality of global warming. In any case, of course, with "if A then B" thinking, one tries empirically to verify the premise A in order better to establish the conclusion B, and one tries to establish that A really does imply B.

Naturally we try to do all this in the field of UFO studies as well, though with older cases like Socorro the problem, like any scientific problem having to do with bygone times, has its difficulties. Since one has to start somewhere, I do for example reason that *if* Allen Hynek was telling the truth when he told Lonnie Zamora that the Air Force attributed the film fogging to radioactivity, *then* my half-life computations are meaningful. We can't give the late Dr. Hynek a lie detector test. That he may not have told the truth is simply another assumption with its own implications. Frankly, weighty decisions are made every day on the strength of hypotheses far less probable than my working assumption that Allen was telling the truth. There are abundant reasons to think that by 1964 he was already growing uncomfortable with Project Blue Book and wanted only to get at the real truths about the UFO phenomenon. (To be precise about what Allen said about the Socorro film: Ray Stanford, author of the definitive book *Socorro Saucer in a Pentagon Pantry*, informs me that he has Allen Hynek *on film* referring, in an interview, to "the fact that the Air Force would not return the film to its owner because it appeared to be fogged as though by radiation.")

California Field Investigator Anthony Tambini suggests an alternative to the radioactivity premise—that Ted Jordan's film may have been fogged by ambient heat. This is a thoughtful suggestion, but I would point out that if such were the case, then his film should very *often* have ended up fogged, since according to witnesses he always kept a camera in his (usually hot) car. If Jordan's film had always gotten damaged that way, why would he have bothered to carry a camera in his car at all?

Both Mr. Wilson and Mr. Tambini point out that I mentioned pockets of uranium in the gully, which they feel would complicate the matter. Actually I should have mentioned in my original article that my Geiger counter readings were far too low (typically around 110 microRoentgens) to account for fogged film, and that I have taken many photos myself in the arroyo with a film camera without any fogging effects.

It is undeniably true that we should keep our standards of scientific thinking high in this field, which is precisely why I have not anywhere claimed to *prove* the extraterrestrial nature of the Socorro craft, but rather have offered some supporting evidence pointing in that direction, expressly and openly contingent upon certain working assumptions.

The certainty of absolute proof in this business is hard to come by, because it's pretty hard to come by anywhere. We need to strive for it. But our fellow scientists should (and will) understand better than anyone else that contingent thinking is the logical structure that moves us forward—in slow and uncertain steps, usually, but forward nonetheless.

OBITUARY...

Robert Lee "Bob" White. Born March 26, 1931-

died November 16, 2009 of injuries received from a car accident near his home in Reeds Spring, Missouri. Bob (a.k.a. Frank James) was a musical entertainer and appeared as an actor in a number of feature films. In 1985, Bob's had a UFO encounter near the Colorado-Utah border where he recovered a metallic "object" he said fell from the UFO. The object remained controversial, but he passed a polygraph test and received media recognition from newspapers, paranormal radio



shows, and national entertainment news shows The object emitted an electro-magnetic field and ratio tests for the element strontium fell within the range of two established Martian meteorites. Bob White was one of the few in ufology who was dedicated to finding the truth of what he recovered in 1985 in Colorado from his UFO encounter. The world has lost a most honest, sincere person and will be missed dearly.

UFOs & The National Security State: The Cover-up Exposed, 1973-1991, Vol. 2 by Richard M. Dolan:



As Elijah the prophet passed his mantle of power on to Elisha (2 Kings 2:13), so has David Jacobs passed the baton of UFO historian from himself to Richard M. Dolan. Jacobs began his UFO research with his history of The UFO Controversy in America, but then moved on to abduction research. Richard Dolan seems likely to stay with history. His monumental first work, UFOs and the National Security State: An Unclassified History, 1941-1973 (published in 2000) has been

followed by this sequel, covering the period 1973-1991, and Dolan expects to complete the trilogy, covering the current period. Anyone seriously interested in UFOs is indebted to Dolan for this enormous effort.

Dolan's point of view is not that of MUFON. As the mission statement of MUFON says, "MUFON's mission is the scientific study of UFOs." Dolan is a trained historian, not a scientist. His point of view as an historian is based on this inconvenient truth: scientists control science, but politicians control scientists, particularly if scientists are doing anything that is of interest to "the national security state." There seems little in the UFO field that the national security state does not seek to control, including private UFO research organizations. Dolan is not the first to suggest that NICAP was done in by the CIA, and when the Lorenzens passed away, their APRO files were scooped up by two persons who will not share them with UFO researchers. Should we be surprised? (p.



441) Most private UFO organizations lack the funds to be effective. The fact that MUFON still exists may be no small miracle, and we cannot help wondering who is watching us behind the mirror of the national security state.

Dolan presents nine chapters, in chronological sequence, with each chapter covering two or three years adding up to almost two decades of UFO history. There are hundreds of reports from around the world gathered from private citizens, military personnel, radar reports, airplane sightings, landing reports.

MUFON readers see these reports as our steady diet. It was during this period that UFO abductions became a major area of UFO research, with Budd Hopkins pioneering in this field. Dolan also does well summarizing the major events, such as Malmstrom Air Force Base, Montana (1975), the Rendlesham Forest story (December 1980), the Gulf Breeze sightings (1987), which greatly divided CUFOS and MUFON leadership, as well as the Hudson Valley sightings (1983-86). Dolan draws heavily on Philip Imbrogno for his Hudson Valley material, and reports that Imbrogno had contact with a man from the National Security Agency, who requested some UFO related tape in Imbrogno's possession. When Imbrogno refused to give up the tape, the comment of the agent was, "you know, Phil, the government has done away with people for a lot less." (p. 340)

BOOK REVIEW UFO...(CONT.)

Dolan deals with MJ-12, the problem of document authentication, names like Richard Doty, Bob Lazar, William Moore, John Lear, and Milton William Cooper, appear as Dolan tries to separate real inside information from disinformation. Dolan goes at the familiar questions. What is going on in Area 51? What have our Presidents known, and have they tried to release UFO information? What is the meaning of Ronald Reagan's strange public comments about UFOs and possible alien invasions? What have the Russians known? Or the Chinese?

He tries to determine if contact with aliens has occurred, and whether or not communication between them and our political leaders has happened.

Several of the "insider comments" from those like Bob Lazar have suggested that the aliens claim to have directed the biological development of humans, and have also directed our religious development (p. 477), perhaps even putting Jesus on earth. Dolan does not explore the issue, but religion is kind of the "wild card" in the UFO cover-up. The Roman Catholic Church has recently been holding a conference on astrobiology, exploring the possibility of life on other planets. This is seen as "radical" by the world press. Would the NSA, or CIA, use religious "disinformation" to frighten away those-like President Carter-who might want to release UFO information? Would any president want to announce that Jesus was put on earth by aliens? The issue is not just about alien contact, but what kind of lies the NSA and CIA might attribute to the aliens.

Dolan moves beyond "mainstream" UFO research when he speculates about political power groups above and beyond the control of the United States, like the Trilateral Commission, and the Bilderberg Group, which he says may be the ultimate groups controlling both UFO secrecy, and the "farming out" of UFO secrets to international technological conglomerates like Lockeed Martin. Dolan speculates "there exists the possibility of what I have come to call a 'breakaway civilization.' This would entail a situation in which black world science and technology" has led to a secret and separate civilization, beyond the control of the United States Congress, or any nation. (p. 580)

Dolan completes his work with an extensive bibliography, and detailed index.

The scope of Dolan's work is beyond easy summary. The importance of this work is not so much in the UFO facts it provides as in the political analysis that seems to flow from this basic proposition: the governments of the world have lied to us for more than half a century about UFOs. How do we really know that these lies are for our own good? What has happened to government of the people, by the people, for the people? From MUFON's point of view, these are not scientific questions. But they are questions MUFON should not ignore.

THE MAN WHO SAYS "UFO"

In May of 2009 I was contacted by an associate producer for the new "MysteryQuest" series airing on History Channel. As State Director for MUFON in Nevada since 2005 I have gotten many phone calls like this one over the years. Nevada is home to the Groom Lake Country Club you know. It has been a practice of mine to turn down invitations to participate on-camera for programs like these. Since 1975, my professional background has been broadcast television and I feel I've been around this business long enough to understand the agendas and the backside of television producing.

Bottom line in a hurry... Networks are not interested in solving the UFO mystery and they never will be. They hire journalists who only scratch the surface of a subject like UFOs just enough to fill 45 minutes of content. A journalist's job is to provide opposing views on a subject and "let the viewer decide." This releases the Networks from the liability associated with taking a side and admitting UFOs are real and mankind here on Earth is not responsible for them. I've been just as aggravated as each and every one of you reading this article when I see every new entry in Network UFO documentaries. That's why I have said "No" to every producer who has called. That is, until recently.

Back to May of 2009. I asked the MysteryQuest producer what made their program any different than all the other attempts at researching and reporting the facts about UFOs. She was quick to answer that their mission was to explore the mysteries of the Earth and incorporate sound science to reveal the truth. The only thing I could say to her was, "And you want to do *yet another* UFO show on Area-51?" Un-phased by my comment, she proceeded to ask if I knew of any UFO "crash sites" located near Area-51 where they could send an expedition to try and find debris and have it scientifically tested. I laughed and had to tell her honestly that I knew of no place where an alien space craft has crashed around the perimeter of Area-51.

Thinking to myself I figured that if they are willing to hire scientists so MUFON doesn't have to, it might be advantageous to cooperate with the producers of the program. But Area-51? I tried my best to discourage the young lady from making the trip to Southern



Nevada with a crew and suggested that if they were honestly interested in getting trace evidence for scientific analysis, they should talk to

none other than Ted Phillips. I explained who Ted was and what he has been doing all these years. "If you want evidence to take to science" I insisted, "then you need to do a show with Ted Phillips!"

In one ear and out the other. Sound familiar?

All she had on her mind was Area-51 and her goal was to get me involved as a representative of MUFON in Nevada. Even though I knew where it would lead and how the program would eventually play out, I decided at that moment to change my mind and agreed to participate in the expedition with MysteryQuest to the E.T. Highway and the secured borders of Watertown. I figured it would be a great personal research project to see for myself if I was right about how History Channel producers have their assigned agenda going into a project and how it would end up on your ty screen. Let's just say, I wasn't disappointed!

And so began my involvement in what became History Channel's MysteryQuest program "Alien Cover-up" which premiered this past Wednesday night, October 14th, 2009 at 10:00 p.m. Upon arriving in Rachel, Nevada to begin three days of shooting with the MysteryQuest crew I met Mr. Peter Merlin from The X-Hunters. Peter is an Aircraft Historian and Aerospace Archaeologist and co-founder of the X-Hunters Aerospace Archaeology Team. Peter's roll in the production of the show was to bring his vast experience in researching the history of Area-51 and terrestrial aircraft crash recovery sites.

I was the man who says "UFO..."



THE CUTLER TWINING

There has been a rash of new claims made that all Majestic 12 documents are obviously fraudulent. No evidence has been provided. Evidence that three documents are real has been ignored. Some of the claims are absurd such as those by Debunker Brian Dunning who claimed on his blog that Phil Klass found that the forger was me. Supposedly Klass asked the world about the type face on the 1 page Cutler Twining Memo presuming that anybody who provided examples of the typeface must have had real materials to copy from. Obviously Dunning had read none of the literature about my research such as reported in "Final Report on Operation Majestic 12"(1) or TOP SECRET/MAJIC (2), or my response (3) to Brad Sparks MUFON Paper (4). The fact of the matter is that Klass had challenged me by letter () about the PICA type used on the CTM claiming that he had 9 samples from the Eisenhower Library of NSC documents showing that the proper type face would

have been Elite not PICA. He challenged me (nobody else, and not publicly) to provide any genuine NSC documents meeting several criteria and using the same size and style Pica type as used in the memo. He offered me \$100. each up to a maximum of 10. I sent him 20 pica type documents from my files having made a number of trips to the Eisenhower Library. He allowed 2. I was going to the EL and easily spotted 14 more there which I copied and sent him with an invoice for \$1000. He paid me. Then he got very upset and threatened to sue me to keep me from including a copy of his check in Ref. 1. I told him I "Xeroxed" the check, cashed it at the bank, and that I could do whatever I pleased with the "Xerox" copy. He had told a lot of people about challenging me. Apparently he told no one about paying me. He of course had never been to the EL. This correspondence is in Reference 1 for anybody who cares about the truth to see. Obviously Dunning does not. The check is also included in "Flying Saucers and Science" (5)

Perhaps it should be noted that the CTM is a one page carbon copy on Dictation Onionskin paper. It was manufactured by Fox paper, was sold only in bid lots and not in stores. The Government bought lots. It is the only original MJ-12 document we have. It was folded when it was found at the National Archives by Bill Moore and Jaime Shandera in July 1985. They called me the same day and read it to me and I,of course, noted that one of the sentences sounded like a document found in the Twining papers at the Library of Congress Manuscript Division a few years earlier. The CTM is at the National Archives for anybody to see and photograph. Two things that show up in a photograph are very important, namely the watermark and the slant red pencil line through the unusual security marking of TOP SECRET RESTRICTED. Xerox copies, of course ,will not show the watermark or that the line is red. Dr. Bruce Maccabee was able to photograph the memo in color while being held against a window at the Archives

It should be noted also that one of the reasons Jaime and Bill went to DC was a post card received many months earlier with hints that strongly suggested a DC trip would be useful. ... mentioning Reese's pieces (Ed Reese is the archivist we have dealt with), Suitland (another DC area Archive) etc.. and supposedly coming from Box 189 in Addis Ababa, Ethiopia. Also I had determined during a DC trip to attend a nuclear conference in March,1985, when I visited Ed, that Senator Russell had had an interesting UFO sighting, just declassified, and that the USAF Record Group 341 (Entry 267) was being classification reviewed. These were USAF HQ Intelligence files from about 1948 on. I kept checking and found that the review was finally completed at the end of June which is why B and J went there. They ordered a bunch of archive boxes of Entry 267 and were going through them when they found the folded CTM between manila folders. It had nothing to do with the folders. Turns out that was Box 189. Ed made a copy for them and they sent me one. Part of it was light bleached.

The archives put out a listing of comments about the document. Some of these were false. For example, it was claimed by the EL that all of the carbons of Cutler's memos were on onionskin with an eagle Watermark. It was also claimed that there was no NSC meeting on the day in question. They also claimed that TSR was not in use until years later. The comments were based on a very limited review of documents just as Klass's foolish notion that all were in Elite type. At the EL I found a number of onionskin carbons on other kinds of paper. CT does not say NSC meeting, only White House

meeting. That these were changed by the NA is usually not mentioned by the debunkers. The GAO in its search for various files concerning Roswell noted that they in a classified archive had found a number of instances of TOP SECRET Restricted being used in the right time frame despite having been told (Majestic 12) that it was not in use at the time. Those documents were still classified, so copies could not be obtained. I found out years later at the EL that the slant red pencil mark was normally added through a security marking to indicate a document was being declassified. I had not known that previously and I know of no one else who had noted it.

An anti argument made for a while by the late Robert Todd, very much anti-Roswell and anti MJ-12, had noted that in papers he obtained by mail from the EL, that Robert Cutler had gone to Europe and was there on July 14, 1954, the date of the CTM, so could not have sent it! Supposedly this proved it was a fraud. His name is at the bottom, but there is no signature and no /s/ indicating "original signed by". If it had been signed, it would have been a fraud. RC left instructions on July 3, 1954, for James Lay, Exec Sec. of the NSC, to keep things moving out of his in- basket while he was gone. In going through an archive box with many Cutler items, I found a withdrawal sheet for a 2 page classified memo from James Lay to Cutler while Cutler was overseas clearly indicating that Lay was indeed looking after things for him. It had taken me two years to get it declassified in response to my request for mandatory classification review of the item. I had also obtained proof that Lay had met with Ike earlier on July 14 and that there had been a phone conversation between them after 4:30. From people at the Truman Library I had learned that George Elsey who had worked for Truman all the time he was in office (and for Roosevelt before that) was still alive. I called him and asked if I could send him the EBD, TF, and CTM. He said yes. I, sent them to him and called him back in a few weeks and learned a great deal about how Truman worked, that often items were prepared for his signature elsewhere and often the date had to be added when they were finally signed. This is relevant because the numerical date 24,1947, on the TF memo is not aligned with the September. I also learned that Cutler and Lay sat next to each other at NSC meetings and that they each got copies of the items written by the other. He also indicated that of course Lay would have prepared something like the CT memo for Cutler while he was gone. No big deal at all. I asked him directly if he could see any reason that the documents could be considered fraudulent. He said NO. I also asked him if he knew of any reason Truman would not have named one of the MJ-12 group to such a job. Again the answer was NO.

Brad Sparks in a very long MUFON Symposium article (5) tried to claim that the CT memo was an emulation of the memo that had been found by Moore and I in the LCMD. As I pointed out in a detailed rebuttal of this and numerous other false claims, this was simply not true. There was one sentence that was quite similar. As I was informed by General Twining's aide (also his pilot) that was standard terminology indicating that no reply was required if you are in agreement. I had found that 7 of the Tim Cooper MJ-12 documents had indeed been emulations of original published documents I had located including 3 in General Albert Wedemeyer's book "Wedemeyer Reports". The emulations were almost word for word with a very few changes the same as the originals as was obvious when held next to each other. Furthermore the hand written signatures, "I approve" etc. were not only identical, but were in the exact same locations on the page as the original; hardly likely at all. They almost all also had false information when carefully examined. The LCMD item was much longer (19 lines vs. 7) than the CTM and differed in other respects as well.

It is also of interest that Box 189 was first handled within 2 weeks of when the last surviving MJ-12 member (Jerome Hunsaker) had died in September, 1984. The roll of film on which the Eisenhower Briefing Document was included was received in December 1984. Numbers on the edge of the 35mm film indicated that the film had been manufactured within a year of when it was received. Hunsaker's death was noted in the NY Times. He had been the last survivor for over a year. It would seem someone was waiting. Unfortunately, the National Archives would not give me the names of the people doing the classification review.

In summary then, I have been unable to find any worthwhile argument against the legitimacy of the CTM. Submissions are solicited. The references cover a great deal of other data about the MJ-12 documents. Stanton T. Friedman www.stantonfriedman.com. email fsphys@rogers.com





New Zealand Bright Orange Lights


KERIKERI -- While facing the eastern sky over the Bay of Islands in Kerikeri, my friend and I were sitting in our car staring at the night sky on November 13/14, 2009, between 11 pm and 2 am. A bright orange light appeared over the tree line low in the sky and turned on and off for hours.

The light was joined by more and these bright orange lights began to move in fast and erratic directions just above the tree line for about five minutes and then suddenly vanished. Two lights higher in the night sky, not too far apart began to move in unison with each other. They were teetering almost, as one moved up, the other moved down, and so forth. This happened for hours until they became stationary, and the orange light from before appeared again above the tree line.

Then the light on the ground disappeared, and the two lights in the sky began moving in unison again. This happened for hours, and we began to scan the rest of the night sky, discovering two other pairs of lights of the exact brightness teetering identically like the first ones we saw. Another object was also spotted with three lights that seemed to be slightly rotating. We were almost able to distinguish a shape that connected the different pair of lights. There was no rational explanation for these lights and their actions, so we made two police reports to the Auckland Police Department, who contacted Kerikeri police. 
Bummer Report . . .



The report is based on our two measures of UFO Investigation effectiveness. Assigning reports within 72 hours of receipt, and completing all investigations within 90 days of being assigned. The "Assigned" column is a six month running average of the number of cases assigned within 72 hours divided by the total number of cases received in that six month period. The "Completed" column is the number of cases completed beginning sixtytwo (62) days back and going back six months from there (for a total of eight months back) divided by the total number of cases reported in the same period. The "Weighted Rank" is just the average of the two columns expressed as a percent.

To improve your score be sure to assign all cases within 72 hours, and follow-up with your Field Investigators to ensure all reports are completed within 90 days. To be considered complete a report must have been investigated and placed in one of the three completed status codes (Unknown, Hoax or IFO) by you the State Director.

Mars (magnitude -0.8 to -1.3): Moving from Leo into Cancer. For northern hemisphere observer Mars will begin the month standing above the east-northeast horizon about 3 hours after sunset and will be standing above the western horizon at sunrise; by month's end Mars will stand low above the east-northeast horizon at sunset and will stand very low over the west-northwest horizon at sunrise.

For southern hemisphere observer Mars will begin the month rising above the east-northeast horizon about 2½ hours after sunset and will be standing above the northnorthwest horizon at sunrise.

<u>Saturn</u> (magnitude 0.7): In Virgo. For northern hemisphere observers Saturn will begin the month rising above the eastern horizon about 8 hours before sunrise and will be found very high above the southwest horizon at sunrise; by month's end Saturn will rise above the eastern horizon about 4 hours after sunset and will stand high above the west-southwest horizon at sunrise.

For southern hemisphere observers Saturn will begin the month rising above the eastern horizon about 4 ½ hours before sunrise and will be found high above the northnortheast horizon at sunrise.

Other Celestial Phenomena

January 21st: Winter Solstice (Marks the first day of winter for earth's northern hemisphere and first day of summer for the Southern hemisphere).

Conjunctions and Occultations:

January 6th: Saturn 7 degrees north of the Moon.

January 29th: Mars 5 degrees north of the Moon..



For southern hemisphere observers Venus will begin the month lost in the glare of the setting Sun.


Jupiter (magnitude -2.0): Moving from Capricomus into Aquarius. For northern hemisphere observers Jupiter will begin the month high above the south-southwest horizon at sunset and will set below the west-southwest horizon about 3 ½ hours later; by the end of the month Jupiter will be found above the southwest horizon at sunset and will set below the west-southwest horizon about 2 hours later.

For southern hemisphere observers Jupiter will begin the month above the western horizon at sunset and will set below the west-southwest horizon about 2½ hours later.

Bright Planets (Morning Sky)

Mercury (magnitude 2.2 to -0.1): In Sagittarius. For northern hemisphere observers Mercury will begin the month lost in the glare of the rising Sun; as the month passes Mercury will rise above the southeast horizon until by month's end Mercury will rise above the east-southeast horizon about 1 hour before sunrise and will stand above the southeast horizon at sunrise. For southern hemisphere observers Mercury will begin the month lost in the glare of the Sun but will slowly climb as the month passes, by month's end Mercury will rise above the east-southeast horizon about 1 ½ hours before sunrise and will stand low over the east-southeast horizon at sunrise.

<u>Mars</u> (magnitude -0.8 to -1.3): Moving from Leo into Cancer. For northern hemisphere observer Mars will begin the month standing above the east-northeast

horizon about 3 hours after sunset and will be standing above the western horizon at sunrise; by month's end Mars will stand low above the east-northeast horizon at sunset and will stand very low over the west-northwest horizon at sunrise.

For southern hemisphere observer Mars will begin the month rising above the east-northeast horizon about $2\frac{1}{2}$ hours after sunset and will be standing above the northnorthwest horizon at sunrise.
