





2012 End Times Prophecy

Since becoming the Pennsylvania and West Virginia Mutual UFO Network State Director in 2007,

I've had many opportunities to speak about UFOs at Conferences and various radio shows all over the Northeast. My daughter, Vanessa, attends most of these Conferences. She often reminds me that she likes my 2012 talk the best. I coincidentally published "12/21/2012 A Prophecy" within weeks of becoming a MUFON State Director. What follows is an outline of my 2012 talk which covers various cultures and new age thoughts along with scientific facts.

All over the world, doomsday vaults are being built. To be precise, 1400 seed banks are being built and managed by the Global Crop Diversity Trust Board. These vaults are deep within mountain ranges at 300 feet above sea level and house millions

of seeds at -1 degrees and can store them for 1000 years. These vaults must be completed by 2012 and serve to safeguard against asteroid strikes, nuclear wars, climate change, and natural disasters.

In 2004, the asteroid Apophis was discovered. Apophis, also called Apepi, Apopis or Rerek, ancient Egyptian God of chaos who took the form of a serpent and, as the foe of the sun god, Re, represented all that was evil. Although the serpent generally symbolized divinity and royalty, Apophis inhabited the underworld and personified death and destruction. Each day Apophis encountered Re at an appointed hour in the sun gods ritual journey through the night in his divine bark. The voice of Apophis betrayed him and Seth, who rode as guardian in front of Re, attacked him with daggers, slaying him. The ancient Egyptians thought they could help Re by reciting payers against Apophis. (Encyclopedia Britannica)

Project SpaceGuard was formed in 1998 by NASA to identify all near earth asteroids. There are 1100 such objects larger than one mile wide. The categorizing was to be completed by 2020. The United States and China have the greatest likelihood on a strike. The asteroid Apophis has been tracked since 2004 and will be tracked for years. These size asteroids strike the earth every 70,000 years. It is one half mile wide and passes the earth every seven years. It has a 2.8% or 1/37

500 megaton bomb. Apophis is not a planet killer, but it would wipe out a large city or small country upon


impact. Its trajectory is across the Yucatan peninsula and across the Atlantic Ocean towards Nigeria. NASA believes it has time to deal with the problem. In 2029, Apophis will pass by at the height of our satellites, skimming the earth's atmosphere just 22,000 miles away. Satellites orbit at 26,000 miles or one tenth the distance to the moon. It was then that corrective action would be taken. We are not technologically prepared to divert an asteroid on such short notice and have not vet tested the technology. It will be visible in the night sky in 2029 from Europe, Africa and Asia.

In April of 2008, I told everyone I knew that Apophis would pass by on the 13th and there should be interesting news in the newspapers and on TV. To my surprise, there was not one news article written on Apophis when it passed by closer to the earth than to the moon. I was stunned that the media would keep this story silent for the "good" of the public.

In March of 2009, with two days notice, the 152 foot asteroid DD45 was discovered. It passed by at twice the distance of our satellites at 44,750 miles from earth. It was the same size as the asteroid that exploded over Tunguska Siberia in 1908 which flattened 80 million trees on 80 square miles. Amazingly, the Siding Spring Space Observatory reported that, "No object of that size or larger has been observed to come closer to the earth". Apparently our Space Observatory never heard of Apophis.

In June of 2009, US satellites that detect asteroids that enter our atmosphere are now classified secret and off limits to the scientific community due to the fact that these satellites also track nuclear test explosions. The data will no longer be released.

It is instances like this that reinforce my belief that the government censors what we are told and that the truth about many anomalies are not told to us.

2012 End Times Prophecy (cont.)

Is the urgency and silence regarding Apophis a cover for a larger more deadly asteroid that has targeted earth or do they know that Apophis will strike on its next go around?

The Mayans, Toltec's, Hopi Indians, I-Ching, and Hindu Kali Yuga all have 2012 or end time prophecies. Nearly every culture has a legend of the Great Flood . . . because it did happen.

The Mayan culture lasted from 300 BC to 1500 AD. The period I will review is from 300-900 AD. This Stone Age culture suddenly developed suspension bridges, astronomy, medicine and the most accurate calendar we have ever seen. More accurate than our Gregorian calendar because they started at 12/21/2012 and counted backward. Mayan records say that a dark rift exists in the center of the sky. In 2002 we discovered a black hole at the center of our Milky Way Galaxy. In 1993 we discovered that from the earth's view, the sun will rise in the center plane of the Milky Way Galaxy on the morning of 12/21/2012. This happens every 25,800 years due to the fact that our rotation changes by one degree every 72 years. The Mayans have three calendars which end on 12/21/2012 and one is on a 25,800 year cycle. The last Ice Age started 25,800 years ago and marked the end of Neanderthal and the rise of Cro-Magnon man. Will there be another change for Homo sapiens? The Jewish 7000 year calendar also ends around 2012 and the Kyoto treaty expires in 2012. The solar cycle of sun spots peaks in 2012 and every summer has been hotter than the previous since 2000 (except 2009).

The most sacred Mayan text is the Popul Vuh which tells of extraterrestrials coming to earth and creating a perfect human species and then destroying it and replacing it with a "dumbed down" version. This is a similar story to older Sumerian tablets found 10,000 miles away.

The Mayan long count is on a 5125 year cycle and also ends on 12/21/2012. Stone Henge and the Great Pyramids of Giza were built 5125 years ago. Some believe that there will be a vibrational shift in our consciousness caused by the thirteen perfectly carved crystal skulls unearthed years ago. The Mayan legend of Kukulcan says that a Caucasian male with blond hair rose from the sea and had an elongated skull. He gave the Mayans their technology and before returning to the sea, he said that he would return. When the Spaniard Cortez arrived in 1519 he was mistaken for the return of Kukulcan. Cortez brought with him diseases that killed 90% of the Aztec population and what remained of the Mayans while he raided their gold and burned their libraries similar to the burning of the Library of Alexandria by the Romans.

The Hopi Indians (500 BC to the present) say that, "In 2012 the earth will be shaken by an explosion that will rock North and South America". There have been three previous great cleansings by an asteroid or

volcano, the Ice Age and a Great Flood. "The Sacred Ones will arrive via Flying Shield". This resembles the Book of Enoch where Ezekiel goes up into a "Flying Wheel". It is also similar to third century Roman writings that described a "fiery shield" crossing the sky. The Hopi's perform Kachina dances where their outfits look like space suits with helmets.

There has been other Hopi prophecy that has come true. "We will talk through spider webs" which has been accepted to be phone lines. "We will ride in carriages without horses. Women will wear men's clothing".

"In the end, a purifier named Pahana will arrive to destroy evil people. There will be flood, famine and hail storms (similar to the Book of Revelation)".

Edgar Cayce, also known as the "Sleeping Prophet", saw the destruction of Japan and the west coast of the United States in 2012. He foresaw upheavals at both Poles and a reversal of hot and cold climates. In the 1920's, he predicted solar bursts or sun spots years before scientists discovered them for the year 2012.

Jean Dixon had a vision of Washington DC as a barren wasteland in 2012. She had a vision of Queen Nefertiti holding a Muslim baby who would grow to be charismatic and a lover of peace at first and then at 50 years old in 2012, become the Anti Christ. President Barack Obama will be 50 in 2012. Jean Dixon also correctly predicted the 1967 Apollo tragedy, FDR's death, the JFK-RFK-MLK assassinations, and that Churchill would lose his election after winning WWII.

In 1124 AD, Father Malachi O'Morgair, the first Irish Saint, named every Pope from 1124 to the last Pope who will be named Peter....same as the first Pope. He said there will be 266 Popes. Pope Benedict is number 265. The end of days will start with the 266th Pope, Peter. The Vatican kept Father Malachi's writings locked away until 1595. Father Malachi also correctly predicted his own death on November 2, 1148 in Clairvaux, France of natural causes.

Zecharia Sitchin, the author of the 12thPlanet, theorized that there is a planet on a 26,000 year orbit that will pass close to the earth in 2012. I always doubted this theory due to the fact that deep space is -434 degrees and solar radiation will boil your blood and dissolve DNA. I read recently that there may be a distant planet on an elliptical orbit that orbits a dwarf star which keeps it warm and cannot be detected until it is very near to earth. Sitchin also speaks of their people being named the Nephilim, same as the Bible.

KNOWING YOUR GEIGER COUNTER

A. GEIGER COUNTER OPERATION:

Geiger counters are good for measuring most forms of nuclear radiation, but not all. Nuclear radiation comes in four major varieties. Geiger Counters can detect three, (3) of these varieties with, relative degrees of difficulty. They can detect beta-particle radiation and to an extent, gamma-ray radiation. They have trouble measuring some weak forms of alpha radiation and cannot detect neutron radiation.

NOTE: AN ACUTE HIGH DOSE OF RADIATION COULD RESULT IN RADIATION SICKNESS AND AN INCREASE IN THE CHANCE THAT MANY YEARS IN THE FUTURE, A CANCER OF SOME TYPE MAY OCCUR.

Operating your Geiger Counter is relatively easy.

- Check the batteries. Geiger Counters run on ordinary batteries. Most if not all of them have battery-check setting found on the main on/off switch. The indicator on the dial must fall within the "battery ok" arc or else the Geiger Counter will not operate properly.
- ➤ If the Geiger Counter has an audio on/off switch, turn it on to hear the clicks associated with detection of radiation. This allows you to keep your eyes on the mission at hand while your ears assess the rate of clicks and therefore, the level of radiation or radioactive contamination.
- The meter faceplate will have printed on it "CPM", for "Counts Per Minute". In a background or natural radiation field you will probably hear and read a bout 0 to 50 CPM. That is normal and is the baseline from which you measure excess radiation. If you get a higher reading while measuring background, it could mean that you are already in a higher radiation field. Move to an area that you know to be radiation-free. If the Geiger Counter still reads high, the probe may be contaminated with radioactivity or perhaps the Geiger Counter malfunctioning. To eliminate the possibility of contamination, the Geiger Counter probe should be cleaned and background tested each before

- To make meaningful measurements, the Geiger Counter probe should be pointed directly at surfaces. For example, hard forensic physical evidence found at the scene of your investigation. You may find you are checking objects such as people, trees, vehicles, buildings, etc. to test these surfaces, point the open end of the Geiger counter probe at the object. Short range radiation, like beta particle radiation, may not be detected unless the probe is within inches of the suspected contaminated surface. A relatively slow scan is advised to allow the Geiger Counter to respond.
- It is best to keep your meter faceplate multiplier at the lowest setting for the greatest sensitivity. It becomes as simple as the more rapid the "CPM" the stronger the radiation.

AT WHAT POINT DOES IT BECOME HAZARDOUS TO YOUR HEALTH?

The "REM" unit describes how much radiation exposure a person can safely receive from a source of radiation. To determine the hazard from radiation exposure, it is far easier for radiation specialist to use the rem unite than to use the cpm unit. Fortunately, many Geiger Counters can read out in both cpm and milli-rem per hour.

NOTE; REMEMBER THIS.... IF YOU GEIGER COUNTER IS NOT CALIBRATED AND THE READING IS INACCURATE, AND ALL THOUGH THAT IS A BAD SITUATION IT IS NOT AS BAD AS IT MAY SEEM FOR THE INACCURATE READING IS ALWAYS HIGHER THAN THE ACCURATE READING. THAT IS MUCH BETTER THAN THE READING BEING LOWER THAN THE ACCURATE READING. ONE MUST SIMPLY KNOW THE LIMITATIONS OF THE GEIGER COUNTER WHILE USING IT.

Knowing you Geiger Counter (cont)

Despite the limitations of Geiger Counters, there is no other rapid means of radiological assessment under emergency conditions. Right or wrong, exposure rate measurements will be used to either deploy or pull back investigative personnel involved in the incident.

Radiation doses of sufficient magnitude will induce acute radiation sickness (ARS). Such doses are approximately in the range of 100,000 m-rem and above. It is known that on average, a dose of about 400,000 m-rem will be lethal about 50% of the time without medical intervention.

MILD RADIATION SICKNESS

Signs and symptoms resulting from an acute absorbed dose of 1 to 2 Gy may include:

Nausea and vomiting within 24 to 48 hours Headache Fatigue Weakness

MODERATE RADIATION SICKNESS

With an acute absorbed dose of 2 to 3.5 Gy, a person may experience:

Nausea and vomiting within 12 to 24 hours

Fever Hair loss Infections
Vomiting blood Bloody stool Poor wound healing

Any signs and symptoms associated with a lower absorbed dose

SEVERE RADIATION SICKNESS

An absorbed dose of 3.5 to 5.5 Gy can result in the following signs and symptoms:

Nausea and vomiting less than one hour after exposure to radiation

Diarrhea High fever
Any signs and symptoms associated with a lower absorbed dose

Severe radiation sickness is fatal about half the time.

VERY SEVERE RADIATION SICKNESS

A person with an absorbed dose greater than 5.5 to 8 Gy can have the following signs and symptoms:

Nausea and vomiting less than 30 minutes after exposure to radiation

Dizziness Disorientation Low blood pressure (hypo tension)

Any signs and symptoms associated with a lower absorbed dose

Very severe radiation sickness is often fatal.

TREATMENT FOR INTERNAL CONTAMINATION

Some treatments may reduce damage to internal organs caused by radioactive particles. Medical personnel would use these treatments only if you've been exposed to a specific type of radiation. These treatments include the following:

POTASSIUM IODIDE is a nonradioactive form of iodine. Because iodine is essential for proper thyroid function, the thyroid becomes a "destination" for iodine in the body. If you have internal contamination with radioactive iodine (radioiodine), your thyroid will absorb radioiodine just as it would other forms of iodine. Treatment with potassium iodide may fill "vacancies" in the thyroid and prevent absorption of radioiodine. The radioiodine is eventually cleared from the body in urine.

<u>PRUSSIAN BLUE</u>, a type of dye, binds to particles of radioactive elements known as cesium and thallium. The radioactive particles are then excreted in feces. This treatment speeds up the elimination of the radioactive particles and reduces the amount of radiation cells may absorb.

DIETHYLENETRIAMINE PENTAACETIC ACID (DTPA)

is a substance that binds to metals. DTPA binds to particles of the radioactive elements plutonium, americium and curium. The radioactive particles pass out of the body in urine, thereby reducing the amount of radiation absorbed.


The small country of Scotland is known for many things: its beautiful scenery, whiskey, the Loch

Ness Monster, Braveheart, but not UFOs. But this new book *UFO Case Files Of Scotland* by Scotland and one of the UK's leading UFO and Paranormal researchers, Malcolm Robinson, could well alter all that.

Malcolm Robinson has been involved first hand as a UFO and Paranormal researcher since the late 1980's. A true Scot in every sense of the word Malcolm has been at the forefront of research on UFOs in Scotland and the only thing that truly surprises me about this book is that it is his first one. Having read it from cover to cover I can only hope it is the first of many.

UFO Case Files Of Scotland is in no way definitive, it is instead an honest reflection of Malcolm's own involvement in UFO research in Scotland. It might not be definitive but of the cases that it covers it is certainly in-depth. I have read literally hundreds of UFO books down the years and I can honestly say, in the best possible way that I can, that this book is like no other. Not only does Malcolm go into great detail of the case histories featured, but he also gives a very graphic description of the mood and atmosphere of the time. Details of lectures and conferences are covered, one or two of the more humorous moments also, and Malcolm is also man enough in this book to hold his hand up when he made a mistake or two, all of which of course is to his credit.

The case histories covered are no less fascinating. In the first chapter Malcolm briefly outlines how and why he became involved in this research in the first place. This is followed by the best coverage I have ever read of the Bonnybridge 'UFO HOT SPOT'. In the early to mid-1990's, the small town of Bonnybridge was the centre of UFO activity in Britain and some may



soon realised when reading this chapter that I knew virtually nothing.

Other case histories featured are the Robert Taylor UFO landing account in Livingston of November 1979. With physical traces left on the witness and the location (marks in the ground) this incident was officially investigated by the local police. The A70 Incident is Scotland's first reported UFO abduction account and it is featured here in full. This particular event is now under consideration for a movie by a UK production company. The Fife Incident took place in September 1996 and involved several witnesses. A controversial case of UFO entities and a whole lot more is again dealt with in-depth by the author. Scotland's and probably Britain's best

UFO photographic case took place at Craigluscar Reservoir in Scotland on February 19th 1994. The full story of this daylight UFO photographic case is covered with the photograph in question featured in full. The book is rounded off with Malcolm's own look at what UFOs may be.

I have purposely not given too much detail of the UFO case histories featured in this book because to offer brief details of them simply would not do them justice.

Like I said at the beginning this is no ordinary UFO book. UFO Case Files Of Scotland is a highly significant contribution to the UFO research literature. It is written in a different style to any UFO book I have ever read and all I can say is that if you are only going to buy one UFO book this year then you could go a long way before you find a better one than this. Put it on your shopping list now.

THE MAN WHO SAYS "UFO"

This is the continuation of Mark's behind the scenes experience as the UFO Expert on the MysteryQuest program "Alien Cover-up" which originally aired October 14th, 2009 at 10 pm on History Channel. Part 1 of this story was in MUFON's Journal last month.

Before I agreed to being involved with the production I had asked what they expected from me as a representative of MUFON and what they were anticipating to find upon launching a scientific expedition. "We're going to search the boundaries of Area-51 and hopefully find debris from crashed vehicles" the associate producer explained. She then asked if I knew of any "alien" crash sites located around Area-51. I had to honestly tell her no.

"What kind of a program is this?" I asked the A.P. at this point. She replied, "It's the sequel to MonsterQuest. Our show will explore a wider scope of un-explained mysteries bringing science to task in solving these mysteries." Sounds noble enough, I thought to myself, but what do they expect to find and take to science? That's when she mentioned the "OxCart" program which was a black budget C.I.A. operation that has been recently declassified. But wait, there's nothing alien about the OxCart program. This secret program developed the successors to the U-2 Spy Plane; The Archangel or A-12, and the SR-71 Blackbird. There's nothing "alien" about these aircraft.

She continued, "We would like to have you participate in an expedition into the Nevada Desert to search a crash site of an experimental vehicle that was launched from Area-51 previously researched by Peter Merlin. He says we may still find debris in the area surrounding the crash site which he had discovered two years ago." She got more excited as she described the rest of the expedition, "Then, we'll place surveillance cameras in the vicinity of the Black Mailbox, drive to the gates of Area-51, then top it off by bringing the biggest lense ever assembled on a Hi Definition camera to the top of Tikaboo Peak." I thought to myself, "Hasn't this been done before?"

Obviously the producers of the show had already gotten a gameplan together and it was Area-51 or bust. So, I decided to say yes and the rest is how we say, "History."

On Sunday, June 21st, 2009 I flew into Las Vegas, got my rental wheels and set out for the Extraterrestrial Highway. The E.T. Highway is actually Highway 375 in Southern Nevada. My destination was the remote town of Rachel, Nevada and the Little Ale Inn. It was there that the cast and crew would meet and discuss the next



three days of shooting. I pulled into the parking lot at the Inn just as the crew was unloading the gear from the production vehicle. "And all of this is going to the top of

Tikaboo Peak?" I asked myself.

That's when Peter Merlin arrives. And he has brought with him a 250 pound pile of crash debris. "What the heck is that?" I ask as the plot thickens. "It's the nose cone from a rocket that propelled an unmanned drone from Area-51 back in 1967." Apparently Peter had researched the crash site located in the Railroad Valley near Area-51, and had gone out and discovered this huge pile of debris left behind by the military. He said it would make a great visual. I wondered how he was able to get this huge pile of crash-compressed metal, tubing and wires into his jeep.

As the film crew struggles to pull the prop out of his jeep, Peter proceeds to show us the 1,000 pages of tech info and manuals for the experimental rocket. It seems this crumpled pile of steel began as the 10 foot nose cone to a rocket flying at Mach 3 which was now compressed into a 2 and a half foot lump after smashing back to Earth in the Railroad Valley. Cool find, but this is not E.T. crash debris. I could see the producer's brain clicking as she saw this pile of metal for the first time. I knew right there that I may have left sound reasoning at home when I flew out of Reno.

We embarked on our expedition to this crash site early in the morning. It was a long drive with a lot of nothing to see except for the occasional antelope, cow or black crow. When we arrived at the destination, the producer proceeded to explain how the sequence would be shot. We had to pull the huge pile of debris out of Peter's jeep and carry it out and plant it in the desert so on camera we could drive up and "discover" it. This is where the editing magic began.

The first scenes shot were Peter and I kneeling next to the debris and pulling pieces out and talking about them as we pretend we are looking at it for the first time.

Case Report MUFON SIP CAT 2 Deployment
Field Investigators: Charles Modlin, Vicki LeBlanc

On November 25, 2009, a STAR team CAT 2 Deployment was activated on Case #20706 in Port Jervis, New York. STAR Team Investigator Chuck Modlin was assigned as lead investigator. Chuck is the Chief Technical Advisor for STAR Team. Investigator Vicki LeBlanc was secondary investigator. (The following contains excerpts taken from the original case report written by Charles Modlin and Vicki LeBlanc).

Background: The primary Witness is a 41-year old male. This Witness is a medical professional, works in a hospital facility on second shift. is married and lives with his wife at an un disclosed location in Port Jervis, NY. His name and specific information about the location of the event have been withheld to protect the witness' confidentially.

Investigator Report: Investigators met with the witness at his home on 11/27/09.

• The witness works in the medical field on second shift. He leaves work around midnight and takes a route which goes through a rural area with curving roads. Coming around a bend in the road, he could see an object about a mile away, it looked pretty small. As he came to the next turn, he slowed down to about 25 miles to get a better look at the object, which was then almost on top of him.

He stopped his vehicle along the side of the road and remembers putting the car in PARK, with the engine running. He could now also see that the object looked cigar-shaped and was turning clockwise slowly (on axis) as it came towards him. When asked to compare the size of the object to an aspirin at arm's length, the witness said that it would be about the size of a baseball.

- According to the witness description, there were lights (blue, white, red, white and blue in that order) He heard a sound like a cat that was purring at a low frequency (continuously vibrating)
- As the object passed over the witness vehicle, the engine just stopped, as if someone had turned off the ignition. (proximity of 150 feet above) The Witness tried to use his cell phone but it was inoperative, despite the fact that it was charged. He also tried to roll down the electric window but it malfunctioned. He thought about

getting out of his vehicle. He opened the door slightly but then reconsidered and closed the door.

- The Witness reported that the lights on the object seemed very bright but they didn't illuminate the ground. The craft appeared gun metal gray against the dark sky.
- The encounter lasted for about 2 to 3 minutes, then the craft's lights blinked out and the witness's vehicle started up without any action on the part of the witness. He put the car into drive and put the pedal down. He was terrified!

Witness recalled running through several STOP signs on the way home and indicated that he nearly crashed his vehicle into a fence. The witness stated that he actually doesn't want to drive on that road again.

Physiological (Medical)
Effects: Witness
reported that he had a
toothache since his
sighting but didn't notice
any other physiological
effects.

Physical Effects - Investigator Modlin inspected the cell phone and found it to be working properly.



Radiological Survey: Investigators checked the affected Vehicle for radiation, without any unusual readings (consistent with background). Investigators surveyed the site of the event (road side) and reading at the affected area were consistent with background reading.

Electromagnetic - Electrostatic Effects: Investigators did find very significant abnormal readings on the subject vehicle with a tri-field meter. The witness was driving a 2009 Midsize 4 door sedan that was approximately 2 months old.

DISINFORMATION AND ROSWELL

had several calls in Mid November 2009 asking me my views about comments supposedly made by MUFON International Director James Carrion at the Annual UFO Crash Conference in early November in Las Vegas. Some said he

claimed Roswell did not involve the crash of a flying saucer. Others that he suggested it might not have involved such a crash. James was good enough to provide a copy of his Las Vegas paper. James had also mentioned Roswell at the 40th Annual MUFON Symposium in Denver in August. He made a couple of comments there. I responded to one in a public discussion. He had indicated that an alien spacecraft coming from far away couldn't have crashed. My response was that all indications are that none of the saucer crashes which I take seriously, Roswell, Plains of San Agustin, Aztec, Varginia (Brazil) were of very large craft themselves flying here from a nearby solar system. Rather they and the almost 4000 physical trace cases collected by Ted Phillips from almost 90 countries seem to involve small craft under perhaps 60' in diameter. But we have a number of reports involving truly huge vehicles that would make far more sense to me as Interstellar craft, I am thinking of the radar-visual JAL 1628 case of Nov.17.1986, described as twice the size of an aircraft carrier by 747 Pilot Kenju Terauchi and his crew. I am thinking of the craft

seen on December 11, 1996, by more than 30 witnesses in the Yukon Territory and well investigated by Civil Engineer Martin Jacek¹. It was somewhere between 0.5 and 1.0 miles long. I pointed out that aliens are not likely to be perfect and that we Earthlings have lost 2 space shuttles. I also noted that the United States has several huge nuclear powered aircraft carriers (over 1000' long) which can operate for 18 years without refueling. Each of these "mother ships" carries about 75 very much smaller high performance aircraft that can go very fast, but, in contrast, need refueling after a couple of hours. The crashed saucers I consider to be Earth Excursion Modules in analogy with the Lunar Excursion Modules which are very much smaller than the 360' long Saturn Rocket which gets them to the moon. I had discussed these points in my MUFON paper².

James in his MUFON paper focused on the possibility that stories of the Roswell crash may have been disinformation issued to fool the Russians into thinking we might have recovered secret incredibly advanced technological devices. They would then waste time seeking information about these mythical craft. He also suggested that perhaps Kenneth Arnold's famous sighting of a fleet of 9 very high speed (over 1200 mph when the speed record was about 675mph) craft over Washington state on June 24, 1947, two weeks before the purported Roswell crash, might have also been a disinformation plot. I believe anybody reading Dr. Bruce Maccabee's review of that case would disagree.

I am definitely in agreement with James that disinformation is a very important aspect of hot and cold war activities. Certainly New Mexico is no stranger to disinformation and intentional misinformation. When the extraordinary first nuclear explosion was set off at Trinity site on the White Sands Missile Range on July 16, 1947, at 5:29AM, it was seen by people as far as 100 miles away. Many calls were made to Sheriff's offices, police forces, etc. In a few days a totally false story was released indicating that an ammunition dump had blown up and that fortunately nobody was injured. It was only after the nuclear detonations on Hiroshima and Nagasaki, Japan, on August 6 and 9, that the true story came out. The city of Los Alamos, NM, where the scientific work connected with the development of those weapons was conducted was a totally secret city. Nobel prize winning scientists travelled under assumed names. And there were many more examples.

Disinformation and Roswell (cont.)

A very distressing disinformation release occurred on Sept.12, 1945, when the New York Times quoted General T.F. Farrell, Chief of the War Department's mission to Hiroshima, saying that the bomb produced no long lived radioactivity. That was known to be totally false as a result of medical observations of very sick people in Hiroshima a month after the blast.

During World War II there were many examples of Disinformation. The allies made a very elaborate and subtle effort to convince Hitler that the expected invasion of Germany would take place near Calais, France, under General Patton. Instead Normandy was the location. Hitler was fooled and withheld his reserve troops "knowing" that Normandy was just a feint. It was too late when he finally responded.

James goes on at some length about a Project Sear supposedly conducted in secrecy by New Zealand, the USA and the United Kingdom towards the end of WW II. The idea was to see if an artificial Tsunami could be created using underwater explosives and causing a huge tidal wave to wash away the Japanese troops on Pacific Islands. He focused on articles appearing in Mid-June 1947 suggesting the project had been working on something as powerful as the atomic bomb and makes much of the timing of one of the articles being in a newspaper next to one about Kenneth Arnold's sighting. For reasons unknown the articles named 2 professionals involved in the project. James is right to ask what that was all about. Was it to tantalize the Russians? But he provides no link between that story and Roswell or the Soviets.

One question he asks is why nobody of the 509th Composite Bomb group at Roswell was punished for putting out the Roswell press release which certainly made them look like idiots not being able to tell the difference between a weather balloon /radar reflector and a flying saucer. Colonel Blanchard, commander of the Roswell Army Air Field, indeed went on to become a 4-star general and Vice Chief of Staff of the USAF. I would suggest an obvious answer. Rancher Brazel came in to Roswell on Sunday, July 6. Major Marcel and Captain Cavitt followed him out to his ranch that day, stayed over night, and came back late on the 7th with more wreckage. Lieutenant Walter Haut was ordered to put out the press release on July 8. That left plenty of time for Blanchard to have been in touch with his boss Brigadier General Roger Ramey over in Ft. Worth. We know from Retired General Thomas Jefferson Dubose, Ramey's chief of staff, that Ramey in turn was called by his boss General Clements McMullen in Washington to cover up the story which he proceeded to do. Blanchard, DuBose, Ramey and McMullen were all West Pointers. Clearly the process involved the Chain of Command. Blanchard could easily have had the wreckage left by Brazel examined while Marcel and Cavitt were gone. One doesn't get downgraded for following orders, one gets commended .McMullen was acting head of the Strategic Air Command. Also Blanchard was somehow not available for questions.

I was surprised to find that Carrion doesn't mention the story told by Professor Valery Burdakov of the Scientific Geoinformation Center of the USSR Academy of Sciences in a large article in Rabochhaya Tribuna (the Workers Tribune) in August 1991, Professor Burdakov told how he had been told by Sergey Korolyev, the Soviet Union's top rocket designer, that Josef Stalin had ordered Korolyev to spend time in secret reviewing a number of foreign articles about UFOs including about Roswell. Several Translators were provided.

Korolyev told Stalin the saucers seemed to be real, but were not a security threat to the USSR. Stalin said other scientists had provided the same opinion. Burdakov was asked about the source of the information. His answer was from Spies. We now know, of course that there were, in 1947, Russian spies such as the Rosenbergs and Klaus Fuchs working at Los Alamos. Furthermore, Colonel Blanchard's daughter Anne had told me many years ago that she had heard from someone who worked at Los Alamos that the lab had received materials from Roswell for evaluation. Certainly the lab obviously met two required criteria for access to such materials: very high competence and very high security clearances. The discussion about Burdakov and Korolyev (sort of the Werner Von Braun of the Soviet Union) appears in my 1992 book "Crash at Corona" and is also mentioned by Tim Good in one of his books.

James is also concerned as to why in a TOP SECRET document mention is made of Project Mogul. As it happens the notion that MOGUL was very highly classified as claimed by the USAF Roswell debunkers such as the Air Force and Dr.Charles Moore and Duke Gildenberg, is false.

Only the mission objective was classified (listening with a constant altitude balloon for possible Soviet nuclear explosions). Many of the Mogul flights were allowed to just come down to earth and left to rot in the sun.

There was usually no chase plane .None of the technology was classified. The US Army Air Force group at Alamogordo Army Air Field actually launched, for the press, a weather balloon radar reflector combination as shown on the front page of the Alamogordo Newspaper on July 10, 1947. It certainly wasn't anything like a Mogul Balloon train with its 20-24 weather balloons at 20' intervals.

James claims that the failure to reprimand anybody in the 509th is especially hard to understand considering that they were supposedly reprimanded about a classified document that had to be reclassified to a higher level. He shows the reclassification request. I think its is very clearly a standard instruction to reclassify because of a change in security level of the document by the originator and is not a reprimand..

I should certainly agree that the USAF has put out more disinformation about the Roswell Incident than about any other UFO incident. Consider the two monstrous (in size and lack of accuracy in the content) reports "The Roswell Report: Truth vs. Fiction in the New Mexico Desert" (1992 Mogul nonsense) and the "Roswell Report: Case Closed.":trying to explain Roswell bodies as crash test dummies none of which were dropped until at least 6 years later and all of which were 6' tall and weighed 175 pounds. Both are loaded with disinformation as I have discussed elsewhere They wouldn't have fooled the Russians for a minute. They did seem to fool the New York Times and other newspapers which seemed to buy them hook, line, and sinker.

This is when the producer starts asking me to interject the words "alien" and "extraterrestrial" and "ufo" as I examine the debris. What's funny is that I am holding asbestos shielded wiring and stiff hydraulic tubing in my hands and she wants me to act like I don't recognize it for what it is, man made.

After struggling through that scene it was now time to search the desert floor to possibly find by chance more debris while the camera were rolling. An hour and a half later, with triple digit heat and no sign of additional debris to be found, the producer makes a corporate decision. We are to take one of the pieces of metal that we had previously been handling and describing, and plant it out of camera field of view so Mark could walk in and "discover it" for the camera.

After the drama of discovery is over and the supposed "debris of unknown origin" is packaged up, it is mailed to the good professor at Rutgers University for "anaylsis." Since I wasn't involved after that point, I've wondered if they honestly told the professor at Rutgers the true origin of the metal before he did the analysis. I'm guessing not. Please accept my apology for leading the viewing public along in this History Channel program. That's why I am setting the story straight now.

The most exciting event of the entire expedition would have to be the climb to the lookout at Tikaboo Peak. The drama that happened there was real when the Navy jet fighter screamed through the mountain gorge followed by the unmarked helicopter. I just knew right there that I would be going to jail when I reached the main road upon our exit. What the cameras did not show was the producer on her cell phone talking with company lawyers in New York about how we all would be bailed out of jail. Luckily, we escaped the long arm of the law and I made it home safely that evening.

The moral of this story? Producers of UFO programs seen on cable networks are not interested in genuine investigation of UFOs and the truth behind the mystery. Though the MysteryQuest "Alien Cover-up" program wasn't bad overall, it wasn't groundbreaking by no means. So, in the end just another expose' on Area-51.

And I was the man who said "UFO."

SIP - THE STAR IMPACT PROJECT

The STAR Impact Project (SIP) is a program funded by Bigelow Aerospace Advance Space Studies (BAASS) whereby MUFON is subcontracted to provide information on the UFO phenomenon. The SIP project, operational since April 2009, will help us get us closer to understanding the UFO Phenomenon. (STAR stands for Strike Team Area Research; it is MUFON's Rapid Response Special Unit.)

Our Dispatch Operation works continuous shift throughout the day, monitoring CMS and reviewing all the new cases. (CMS is MUFON's online Case Management System.) Deployments involving paid field investigators began in April.

Each month in the MUFON Journal, we feature one or tow of the more compelling cases we deployed on during that month. We will also provide a case listing of all SIP STAR Team deployments for that month

DEFINITIONS OF CATEGORIES

MUFON Dispatch Operator review all cases that come into CMS and part of their responsibility is to categorize each case as a CAT 1, CAT 2, or CAT 3. The dispatchers use a series of questions to categorize each case. The questions are based on the tradition Jacques Vallee Classifications. In brief, the categories can be defined as such:

CAT 1) The witness sees a strange or unidentified light(s) or objects(s) in the sky.

CAT 2) The unidentified light(s) or objects(s) is observed to have landed on the ground or in some way affected the immediate physical environment

CAT 3) The witness also experienced one or more of the following during or after the event:

- A) Observations of beings or entities
- B) Interactions with nonhuman entities
- C) Episodes of missing time
- D) Wounds or trauma to body of unknown origin
- E) Taken onboard a craft
- F) Telepathic communication
- G) Out of body experience
- H) Encounter with an unknown animal

For 37 years, I have offered a religious perspective on MUFON's scientific study of UFOs. In regard to Richard Lang's cover story in the October/November 2009 issue of the Journal, I want to make the following observations concerning the "Men in Black." Some have presumed that the "Men in Black" were government agents, but there have been suspicions they might be "aliens" pretending to be government agents. When I have been visited by Jehovah's Witnesses, they usually come in twos, and are dressed in black. Only one speaks, the other listens. Concerning "Mr. Michael," there are only two angels named in the Bible, Gabriel and Michael. In Hebrew the name Michael means "who is like God," and is named as the "prince of Israel." (Daniel 10:21) The Men in Black show up at 7 a.m. Sunday, "toward the dawn of the first day of the week." (Matt. 28:1) They did not talk like "people native to North Carolina." Assuming that open disclosure of extra-terrestrial contact has been made, we will have interaction with inhabitants from other worlds in varying degrees. Space travel will have advanced considerably from our current earth-hugging efforts. After the initial reaction to the news that we are officially not alone - something that most thinking people already accept anyway - I think that we will adjust very quickly to our new status. As the general public realizes that most people from elsewhere are maybe not all that different to us, their novelty factor will quickly fade.

An analogy can be seen in our own recent history. Not that long ago people dressed in their Sunday best to take an air flight; it was a big event. Now no-one is impressed with commuting to work by air or flights of many thousands of miles. People go into space all the time with little fanfare and tourists pay to fly there. With low-orbit space travel from earth already routine I suspect we will adjust quickly when this expands to include other planets and star systems. As for people visiting from other planets, they may eventually arouse no more 0 interest on our part than someone from another country does now.

My point is this: one way that the UFO-research community, led by MUFON, can help prepare the general public for the coming reality of alien contact is to reconsider the terminology that has grown up with the phenomenon. Instead of referring to "ETs" or "aliens," terms that have strong (and often negative) Hollywood connotations, perhaps we could refer to them as "EVs," or "earth visitors."

Because it sounds similar to ET, a moniker like EV should catch on fast. It would also allow us an opportunity to explain, very simply, what it means. And perhaps someone can improve on "UFO" and the other acronyms we use. But meantime, the EV acronym would help remove the mystique of extra-terrestrials from our cultural conditioning.

By subtly changing the emphasis away from the offworld origin of visitors, we can teach everyone that we live in a universe teeming with life. Some of that life drops by to visit our little corner of the Milky Way. Maybe that classic bar scene will play out for real soon enough.



# Alien worlds spotted outside the Milky Way for the first time

Daily Mail Reporter Alien worlds have been discovered beyond our own galaxy for the first time, according to astronomers. Scientists now regularly find exoplanets within the Milky Way and 403 have been catalogued



since 1995. Erin Mentuch from the University of Toronto made her find far deeper into space. Ms. Mentuch analyzed 88


remote galaxies using data from the Gemini Deep Deep Survey. The light was emitted seven to 10 billion years ago.

The galaxies were far too remote to view stars individually but their light output was found to peak at two distinct wavelengths. The short wavelength was the combined light of a galaxy's stars while the longer came from the glowing interstellar dust.

However, the Ph.D. student noticed there was a faint third component between the peaks. This mysterious light was too cold to be produced by stars but too warm to be dust. Ms Mentuch concluded it was most likely caused by circumstellar discs - swirling clouds of dust and gas forming young solar systems around infant stars. 'It's the most surprising result I've ever worked on,' said Ms Mentuch's PHD supervisor Roberto Abraham. The discovery may show how the rate of planet formation has changed over billions of years. ### Life on Mars



The case for fossil life in Martian bacteria in the now famous meteorite ALH 84001 (Shown above) blasted off the

# Brazil's Minister of Air Force Reveals We Are Being Visited by Cosmic Species

Lieutenant-brigadier Sócrates da Costa Monteiro the former minister of Air Force from 1990 to 1992 was interviewed by Brazilian UFO Magazine editor A. J. Gevaerd, concerning UFO activities. Monteiro had

access to sensitive information on the interaction of alien intelligence in Brazil. He was pilot and commander of key air traffic control units. He stated Alien, "Technology is far more advanced than ours!"








PEORIA -- I saw a UFO on November 24, 2009, I was in the back seat of the car as we drove down the highway, when I saw a white line as if someone drew it with

Investigators conducted electro-static and electro-magnetic field tests on the Witness's Vehicle (SUBJECT VEHICLE) and then went to a car dealer and selected an identical vehicle (TEST VEHICLE) that was the same make model and year for comparison testing.

Both the electro-static and electro-magnetic fields appear to have been dramatically affected. Specific meter reading (as to intensity) were not available, because the meter (pictured) pegged the needle in the proximity of the SUBJECT VEHICLE.

**Summary:** The investigators did not notice any major contradictions in witness testimony, nor did the witness appear to falter in any of the questions of detail.

# **FIRST AID KIT**

A first aid kit is always good to have with you on an investigation as you never know what you may run into.

# Anatomy of a First Aid Kit

A well-stocked first aid kit is a handy thing to have. To be prepared for emergencies, keep a first aid kit in your home and in your car. Carry a first aid kit with you or know where you can find one. Find out the location of first aid kits where you work. First aid kits come in many shapes and sizes. You can purchase one from the RedCross.org store or your local American Red Cross chapter. Your local drug store may sell them.

You may also make your own. Some kits are designed for specific activities, such as hiking, camping or boating. Whether you buy a first aid kit or put one together, make sure it has all the items you may need. Include any personal items such as medications and emergency phone numbers or other items your health-care provider may suggest. Check the kit regularly. Make sure the flashlight batteries work. Check expiration dates and replace any used or out-of-date contents.

The Red Cross recommends that all first aid kits for a family of four include the following:

- \* 2 absorbent compress dressings (5 x 9 inches)
- \* 25 adhesive bandages (assorted sizes)
  \* 1 adhesive cloth tape (10 yards x 1 inch)

- \* 5 antibiotic ointment packets (approximately 1 gram)
- \* 5 antiseptic wipe packets
- \* 2 packets of aspirin (81 mg each)
- \* 1 blanket (space blanket)
- \* 1 breathing barrier (with one-way valve)
- \* 1 instant cold compress
- \* 2 pair of non-latex gloves (size: large)
- \* 2 hydrocortisone ointment packets (approximately 1 gram each)
- \* Scissors
- \* 1 roller bandage (3 inches wide)
- \* 1 roller bandage (4 inches wide)
- \* 5 sterile gauze pads (3 x 3 inches)
- \* 5 sterile gauze pads (4 x 4 inches)
- \* Oral thermometer (non-mercury/nonglass)
- \* 2 triangular bandages
- \* Tweezers
- \* First aid instruction booklet



He mentioned that a recent fireball/UFO sighting in Longmont turned out to be was several parachutists with rigged suits to have fire shoot out the back. In an unresolved case, John pointed out that on September 10, 1951 Lt. Col Baumgardner, a pilot, observed a disc traveling at 900 mph with ground radar returns confirming this

John then focused on Bob Pratt, one of the all time great MUFON investigator. Bob investigating reported UFO sightings in Brazil and other countries. Brazil was experiencing a UFO flap in the late 1970s. This was a UFO attack on several villages in northern Brazil.

In the small city of Colares between 1977 – 1979 there were 514 reported close encounters of the first, second, third and fourth kinds. Bob Pratt, alone, was involved with 371 of these; an extraordinary amount. Later, over a four month period, a military unit was sent in to investigate these close encounters.

Bob Pratt's investigation into these UFO encounters and its physiological effects on the local residents of Colares he discovered some very disturbing facts and statistics:

- There were 514 victims
- The various craft shot light beams down on these residents – some people reported these beams feeling hot in temperature. Some reported them as cold shafts of light
- Town folks were reporting that not only did the craft shoot light down on the roofs of their homes but the light would reportedly penetrate through their roofs and into their homes

- 54 people reported suffering paralysis
- 42 people claimed to be abducted 18 returned in a relocated area
- 30 people reported attempted levitations
- 34 people reported major eye irritation
- 36 residents suffered prolong illnesses
- Many people suffered radiation burns
- 36 town folks had burns on their body with two puncture marks in the center of the burn area
- 10 people died as a result of their burns
- 300 local animals also died

During the meeting, John was asked questions such as: Would most people be sociologically devastated knowing we are not at the top of the pecking order when it comes to intellectual races in the universe? Would the average person still get up and go to work in the morning knowing we are being visited by a superior race?

When John was asked if he ever thought disclosure would occur, he indicated that full disclosure would be economically disastrous.

The report is based on our two measures of UFO Investigation effectiveness. Assigning reports within 72 hours of receipt, and completing all investigations within 90 days of being assigned. The "Assigned" column is a six month running average of the number of cases assigned within 72 hours divided by the total number of cases received in that six month period. The "Completed" column is the number of cases completed beginning sixtytwo (62) days back and going back six months from there (for a total of eight months back) divided by the total number of cases reported in the same period. The "Weighted Rank" is just the average of the two columns expressed as a percent.

To improve your score be sure to assign all cases within 72 hours, and follow-up with your Field Investigators to ensure all reports are completed within 90 days. To be considered complete a report must have been investigated and placed in one of the three completed status codes (Unknown, Hoax or IFO) by you the State Director.

<u>Mars</u> (magnitude 1.0): Moving from Capricornus into Aquarius. For northern hemisphere observer Mars will not be readily visible this month.

For southern hemisphere observer Mars will not be readily visible this month.

<u>Saturn</u> (magnitude 0.6 to 0.5): In Virgo. For northern hemisphere observers Saturn will begin the month rising above the eastern horizon about 5 1/4 hours after sunset and will be found above the southwest horizon at sunrise; by month's end Saturn will rise above the eastern horizon about 3 hours after sunset and will stand above the west-southwest horizon at sunrise.

For southern hemisphere observers Saturn will begin the month rising above the eastern horizon about 2 ½ hours after sunset and will be found very high above the northern horizon at sunrise; by month's end Saturn will rise above the eastern horizon about 1 ½ hours after sunset and will stand high above the northwest horizon at sunrise.

# Other Celestial Phenomena

Zodiacal Light: Zodiacal light will be visible in northern latitudes in the west after evening twilight beginning Wednesday, Feb. 12, and lasting two weeks. The phenomenon is visible only from very dark locations. Zodiacal light is the result of sunlight bouncing off dust grains in our solar system. These grains lie mostly in the plane of the solar system. Look for a pyramid of light in the evening sky somewhat similar in appearance to the light from a city or town just over the horizon.

February 6th: Jupiter 6 degrees south of the Moon.



# **Bright Planets (Evening Sky)**

<u>Jupiter</u> (magnitude -2.0): In Pisces. For northern hemisphere observers Jupiter will begin the month above the southwest horizon at sunset and will set below the west-southwest horizon about 4 hours later; by the end of the month Jupiter will be found above the west-southwest horizon at sunset and will set below the western horizon about 2 ½ hours later.

For southern hemisphere observers Jupiter will begin the month above the west-northwest horizon at sunset and will set below the western horizon about 2 hours later; by the end of the month Jupiter will be found low above the west-northwest horizon at sunset and will set below the western horizon about 1 hour later.


# **Bright Planets (Morning Sky)**

Mercury (magnitude -0.4 to -0.8): Moving from Sagittarius through Capricornus into Aquarius. For northern hemisphere observers Mercury will begin the month rising above the east-southeast horizon about ½ hour before sunrise and will stand very low above the southeast horizon at sunrise; by midmonth Mercury will disappear into the glare of the rising Sun.

For southern hemisphere observers Mercury will begin the month rising above the east-southeast horizon about 1 ½ hour before sunrise and will stand very low above the east-southeast horizon at sunrise; after midmonth Mercury will disappear into the glare of the rising Sun.

<u>Venus</u> (magnitude -4.0): In Sagittarius. For northern hemisphere observers Venus will begin the month rising above the east-southeast horizon about 3 hours before dawn and will stand high above the southeast horizon as the Sun rises; by month's end Venus will rise above the east-southeast horizon about 2 hours before sunrise and will be found above the southeast horizon at sunrise.

For southern hemisphere observers Venus will begin the month rising above the east-southeast horizon about 3 ½

hours before dawn and will stand high above the eastern horizon as the Sun rises; by month's end Venus will rise above the east-southeast horizon about 3 ½ hours before sunrise and will be found very high above the eastern horizon at sunrise.
