Directive Regarding President's EYES ONLY

In the likely event that the subject of unidentified flying objects or unconventional aerial weapons is a subject matter under discussion with the Chief Executive, National Security Council Staff, department heads, the Joint Chiefs, and foreign representatives, a clarification of the question is in order to ascertain the reason(a) for bringing up the subject. A standard response should be suffice to redirect the question. Under no circumstances should a member suggest or by inference, that the subject is classified as a national security threat. In the unlikely event that UFO's overtly display hostile intent towards the security of the United States, as a group, and after consultation, should a full disclosure be made in accordance with the law as required.
